## UVOD

Dragi prijatelji,

U želji da trajno ostanu zabeležene aktivnosti Jevrejske opštine Zemun pokrenuli smo 2006. godine objavljivanje kataloga, na sva ke dve godine, u kome se u slici i reči podsećamo na naš rad.

Ovo je osmi katalog u kome je jasno vidljivo da su sudstvo Srbije i korona virus bez ikakve sumnje uticali na naše aktivnosti i presudno obeležili ovaj period od dve godine. Sudski proces koji se vodi pred Višim sudom u Beogradu protiv četiri jevrejske opštine (Beograd, Zemun, Kikinda i Priština) i legalno izabranog rukovodstva Saveza na čelu sa Igorom Ginzbergom, započeo je pre dve i po godine na osnovu tužbe Roberta Sabadoša. Razlog je taj što su ga pomenute jevrejske opštine smenile na legalno održanoj skupštini Saveza 1. jula 2018. Da se slučaj može brže završiti, naročito ako postoji „politička volja“, svedoči da je usred vanrednog stanja Viši sud proglašio ko je predsednik Jevrejske opštine Beograd. Uz sve to postupak za sudsko imenovanje predsednika JO Beograd trajao je nepunih godinu dana. Da presuda nije doneta bez „spoljnih“ uticaja budi sumnja što se jedna nevladina organizacija, Svetski jevrejski kongres, odnosno njen predsednik Ronald Lauder, zahvalio što je „nezavisni“ sud brzo imenovao predsednika JO Beograda?! Na osnovu njegove izjave možemo zaključiti da mu je drago što taj isti sud još uvek nije imenovao predsednika Saveza.

Dva događaja su ovde jako važni i zabrinjavajući; Nikada se u istoriji jevrejske zajednice u Srbiji nije desilo da krovna organizacija i njen predsednik tuži судu svoje osnivače, a još manje da je sud odlučivao i odlučio ko će biti postavljen za predsednika neke od jevrejskih opština. Zbog evidentnog raspada jevrejske zajednice u Srbiji apelujemo na Državu da sredstva koja izdvaja za rad jevrejskih opština direktno uplaćuje svakoj opštini u skladu sa njihovom veličinom. „Veličina“ se mora i može odrediti brojem registrovanih članova, ali na osnovu nacistickih zakona koji su određivali ko se ima smatrati Jevrejinom.



Kolaboracionistički režim Milana Nedića je sledeći te zakone pohapsio sve Jevreje na teritoriji okupirane Srbije, potom ih je deportovao u logore i na taj način omogućio da okupator izvrši masovna ubistva Jevreja tokom Drugog svetskog rata u Srbiji.

Od održanih događaja na prvom mestu ističemo proslave verskih praznika u 2019. od kojih smo dobar deo održali u našoj sinagogi. Svakodnevni deo naših aktivnosti bio je posvećen borbi za očuvanje jevrejske zajednice u Srbiji. Bez obzira na brojne nepravilnosti u raspolaganju sa budžetskim sredstvima Republike Srbije, koja se jevrejskim opštinama daje preko Saveza, a na koje smo ukazivali podnošenjem krivičnih prijava, nadležna tužilaštva nisu reagovala. Oštro smo reagovali i na saradnju Roberta Sabadoša sa strankom Dveri koja baštini ideje faštiste i antisemite Dimitrija Ljotića, kao i na sramni članak objavljen o Ljotiću u dečijem časopisu „Zabavnik“. Naši članovi gostovali su na svim medijima koji su pokazali interesovanje, kako za našu istoriju ili za naše projekte, tako i za aktuelne sporove u jevrejskoj zajednici Srbije.

Dva značajna projekta uspešno smo završili u 2019. Prvi je bio objavljivanje knjige i izložbe „Pravednici bez medalje“ u kojoj smo pisali o svim pojedincima za koje smo saznali da su učestvovali u spasavanju Jevreja za vreme Holokausta. Drugi projekat je izdavanje knjige „Jevreji profesori medicinskih fakulteta u Srbiji“. Promocije i obeležavanja verskih praznika planiranih za 2020. su zbog pandemije uglavnom odložene, sa izuzetkom promocije knjige i izložbe o Jevrejima profesorima, koja je oktobra održana u Kancelariji za mlade gradske opštine Zemun.

Od ostalih „radosti“ izdvajamo druženja ženskih sekcija Zemuna i Beograda, gde smo mi u dva navrata bili domaćini, ali i naše učešće na sedmom susretu Mahar u Crnoj Gori.

Na kraju, vredno je spomenuti da je Agencija za restituciju vratio JO Zemun dva lokala.

## INTRODUCTION

Dear Friends,

Wishing to record and safeguard for the future the activities of the Jewish Community of Zemun, in 2006 we initiated publication of a biannual catalogue which would be a photographic and written reminder of our work.

This is the eighth catalogue, which clearly shows that the court system of Serbia and the coronavirus have undoubtedly affected our activities and decisively marked this two-year period. The law suit brought forth in the Court of Appeal in Belgrade against four Jewish Communities (Belgrade, Zemun, Kikinda and Priština) and the legally elected management of the Federation headed by Igor Ginzberg, started two and a half years ago, based on Robert Sabadoš' legal complaint. The basis of his complaint was the fact that the a/m Jewish Communities ousted him during the legally held assembly of the Federation on July 1, 2018. That a case may be brought to a conclusion faster, especially if there is "political will", is shown by the fact that in the midst of the state of emergency the Court of Appeal designated a new President of the Belgrade Jewish Community. Moreover, the procedure for the court designation of the president of the Belgrade JC lasted less than a year. That the court decision was not brought without "external" influences is suggested by the suspicion over the fact that a non-governmental organization the World Jewish Congress, or rather its president Ronald Lauder, thanked the "independent" court for the quick designation of the Belgrade JC' president! Based on his statement, we can conclude that he was glad that the same court has not designated the president of the Federation.

There are two events here which are very important and worrying. Never has it happened in the history of the Jewish community in Serbia that the roof organization and its president should initiate a law suit against its founders, let alone have the court deliberate and decide who should be appointed president of any of the Jewish Communities. Due to the obvious disintegration of the Jewish community in Serbia, we are appealing to the authorities with a request that the funds allocated to the work of Jewish communities be transferred directly to each of the Communities, according to their size. The „size" can and must be determined on the basis of registered membership, based on the Nazi laws which determined who was to be considered a Jew. Enforcing those laws, the collaborationist regime of Milan Nedić arrested all the Jews in the occupied Serbia, deported them to concentration camps and thus enabled

the occupying forces to commit mass murders of Jews during World War II in Serbia.

From among the events organized, we wish to point out in the first place the observance of religious holidays in 2019, most of which were held in our synagogue. A part of our daily activities was devoted to the struggle for the survival of the Jewish community in Serbia. Despite numerous irregularities in the disposal of the funds disbursed from the budget of the Republic of Serbia and allocated to the Jewish communities through the Federation, to which we have pointed out by filing suits with the criminal court, the competent prosecution authorities have not responded. We have strongly denounced the co-operation of Robert Sabadoš with the Dveri political party, which follows the ideas of Dimitrije Ljotić, a fascist and anti semite, as well as the ignominious article about Ljotić, published in the children's magazine „Zabavnik". Our members were guests in all the mass media which expressed interest in either our history or projects we have, as well as in the current disputes within the Jewish community of Serbia.

In 2019 we completed two major projects quite successfully. One was the publication of a book and the exhibition "The Righteous without a Medal" in which we wrote about all the individuals of whom we found out that they took part in saving Jews during the holocaust. The other project was the publication of a book entitled „Jews among the Professors of Medical Schools in Serbia". Promotions and celebrations of religious holidays planned for 2020 have mostly been cancelled due to the pandemic, with the exception of the book promotion and exhibition on the Jewish professors, which was held in October, at the Youth office of the municipality of Zemun.

Among the other joyous events, we wish to emphasize the gatherings of the women's sections of Zemun and Belgrade, which we hosted on two occasions, but there was also our participation in the seventh Maher meeting in Montenegro.

Finally, it is worth mentioning that the Restitution Agency returned two business premises to the Zemun Jewish Community.

Agencija za restituciju Republike Srbije, 19. maja 2016. godine donela je rešenje kojim se Jevrejskoj opštini Zemun na ime naknade za imovinu oduzetu u ulici Primorska 3 i 5, danas Rabina Alkalaja, utvrđuje pravo svojine na zgradu bivše sinagoge.

Iako protiv ovog rešenja nije dozvoljena žalba, zainteresovane strane imaju pravo da povedu upravni spor, što su i učinili. Postupak još uvek nije završen, ali se iskreno nadamo da će sve strane u postupku ceniti našu želju da se od nekadašnjeg verskog objekta, koji danas služi kao običan restoran, uspostavi prostor koji će služiti i za promociju kulture u Zemunu.

In its decision dated 19th May of 2016, the Restitution Agency of the Republic of Serbia granted the Zemun Jewish Community the ownership title on the building of former synagogue, as compensation for the confiscated property in Primorska street numbers 3 and 5 (currently Rabin Alkalaja street).

Although there is no right to appeal against this decision, the interested parties have the right to file an administration suit, which has been done. The case has not been concluded yet, but we sincerely hope that all the parties to the suit will respect our wish to see the once religious institution, currently used as a simple restaurant, function as a place which will host activities promoting culture in Zemun.
